A BILL

To provide for the monitoring of the long-term medical health of firefighters who responded to emergencies in certain disaster areas and for the treatment of such firefighters.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be referred to as the “Healthy Fire-
5 fighters Act”.

1 **SEC. 2. FINDINGS.**

2 Congress makes the following findings:

3 (1) Firefighters from the San Jacinto Ranger
4 District responded to the Esperanza Incident wild-
5 fire in southern California in October of 2006.

6 (2) Five firefighters from the San Jacinto
7 Ranger District lost their lives as a consequence of
8 fighting that fire.

9 **SEC. 3. MONITORING AND TREATMENT OF FIREFIGHTERS**
10 **IN DISASTER AREAS.**

11 (a) **IN GENERAL.**—The United States Fire Adminis-
12 tration, after consultation with the National Institute for
13 Occupational Safety and Health, shall—

14 (1) contract with an appropriate, locally based
15 medical research university to conduct long-term
16 medical health monitoring of those firefighters who
17 responded to emergencies in any areas referred to in
18 subsection (b); and

19 (2) in consultation with the Secretary of Health
20 and Human Services, provide for the treatment of
21 firefighters described in paragraph (1) who suffer
22 health-related conditions as a result of responding to
23 such emergencies.

24 (b) **AFFECTED FIREFIGHTERS.**—An area referred to
25 in this subsection is any area which is declared a disaster
26 area by the Federal Government.

1 (c) HEALTH MONITORING.—The long-term health
2 monitoring referred to in subsection (a) shall include—

3 (1) pulmonary illness, neurological damage, and
4 cardiovascular damage; and

5 (2) exposure documentation.

6 (d) AUTHORIZATION OF APPROPRIATIONS.—There
7 are authorized to be appropriated to the United States
8 Fire Administration to carry out this section, such sums
9 as may be necessary for each of fiscal years 2007 through
10 2011.
