1 SECTION 1. AUTHORIZATION OF GRANTS.

3 and Safe Streets Act of 1968 (42 U.S.C. 3758) is amend-
4 ed by striking “for fiscal year 2006” through the period
5 and inserting “for each of the fiscal years 2006 through
6 2012.”.
