## A BILL

To authorize the establishment of the Henry Kuualoha  
Giugni Kupuna Memorial Archives at the University of  
Hawaii.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. HENRY KUUALOHA GIUGNI KUPUNA MEMO-**  
4 **RIAL ARCHIVES.**

5 (a) GRANTS AUTHORIZED.—The Secretary of Edu-  
6 cation is authorized to award a grant to the University  
7 of Hawaii Academy for Creative Media for the establish-

1 ment, maintenance, and periodic modernization of the  
2 Henry Kuualoha Giugni Kupuna Memorial Archives at the  
3 University of Hawaii.

4 (b) USE OF FUNDS.—The Henry Kuualoha Giugni  
5 Kupuna Memorial Archives shall use the grant funds re-  
6 ceived under this section—

7 (1) to facilitate the acquisition of a secure web  
8 accessible repository of Native Hawaiian historical  
9 data rich in ethnic and cultural significance to our  
10 Nation for preservation and access by future genera-  
11 tions;

12 (2) to award scholarships to facilitate access to  
13 a college education for students who can not inde-  
14 pendently afford such education;

15 (3) to support programmatic efforts associated  
16 with the web-based media projects of the archives;

17 (4) to create educational materials, from the  
18 contents of the archives, that are applicable to a  
19 broad range of indigenous students such as Native  
20 Hawaiians, Alaskan Natives, and Native American  
21 Indians;

22 (5) to develop outreach initiatives that intro-  
23 duce the archival collections to elementary schools  
24 and secondary schools;

1           (6) to develop supplemental web-based re-  
2           sources that define terms and cultural practices in-  
3           nate to Native Hawaiians;

4           (7) to rent, lease, purchase, maintain, or repair  
5           educational facilities to house the archival collec-  
6           tions;

7           (8) to rent, lease, purchase, maintain, or repair  
8           computer equipment for use by elementary schools  
9           and secondary schools in accessing the archival col-  
10          lections;

11          (9) to provide pre-service and in-service teacher  
12          training to develop a core group of kindergarten  
13          through grade 12 teachers who are able to provide  
14          instruction in a way that is culturally congruent  
15          with the learning modalities of the kindergarten, ele-  
16          mentary school, or secondary school students the  
17          teachers are teaching, particularly indigenous stu-  
18          dents such as Native Hawaiians, Alaskan Natives,  
19          and Native American Indians, in order to—

20                 (A) ameliorate the lack of cultural congru-  
21                 ence between the teachers and the students the  
22                 teachers teach; and

23                 (B) improve student achievement; and

24          (10) to increase the economic and financial lit-  
25          eracy of college students through the proliferation of

1 proven best practices used at other institutions of  
2 higher education that result in positive behavioral  
3 change toward improved debt and credit manage-  
4 ment and economic decision making.

5 (c) AUTHORIZATION OF APPROPRIATIONS.—There is  
6 authorized to be appropriated to carry out this section  
7 \$5,000,000 for fiscal year 2007, \$10,000,000 for fiscal  
8 year 2008, and such sums as may be necessary for each  
9 of the fiscal years 2009 through 2012.
