## A BILL

To amend title 10, United States Code, to revive previous authority on the use of the Armed Forces and the militia to address interference with State or Federal law, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REVIVAL OF PREVIOUS AUTHORITY ON USE OF**  
4 **ARMED FORCES AND MILITIA TO ADDRESS**  
5 **INTERFERENCE WITH STATE OR FEDERAL**  
6 **LAW.**

7 (a) REPEAL OF AMENDMENTS MADE BY PUBLIC  
8 LAW 109–364.—Section 1076 of the John Warner Na-

1 tional Defense Authorization Act for Fiscal Year 2007  
 2 (Public Law 109–364), and the amendments made by that  
 3 section, are repealed.

4 (b) REVIVAL OF PREVIOUS AUTHORITY.—The provi-  
 5 sions of chapter 15 of title 10, United States Code, that  
 6 were amended by section 1076 of the John Warner Na-  
 7 tional Defense Authorization Act for Fiscal Year 2007,  
 8 as such provisions were in effect on the day before the  
 9 date of the enactment of the John Warner National De-  
 10 fense Authorization Act for Fiscal Year 2007, are hereby  
 11 revived.

12 (c) CLERICAL AMENDMENTS.—

13 (1) HEADING AMENDMENT.—The heading of  
 14 chapter of 15 of title 10, United States Code, is  
 15 amended to read as follows:

**“CHAPTER 15—INSURRECTION”.**

16 (2) CLERICAL AMENDMENTS.—(A) The tables  
 17 of chapters at the beginning of subtitle A of title 10,  
 18 United States Code, and at the beginning of part I  
 19 of such subtitle, are each amended by striking the  
 20 item relating to chapter 15 and inserting the fol-  
 21 lowing new item:

**“15. Insurrection ..... 331”.**

22 (B) The table of sections at the beginning of  
 23 chapter 15 of such title is amended by striking the

- 1 item relating to section 333 and inserting the fol-
- 2 lowing new item:

“333. Interference with State and Federal law.”.
