## A BILL

To amend section 401(b)(2) of the Higher Education Act of 1965 regarding the Federal Pell Grant maximum amount.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FEDERAL PELL GRANT MAXIMUM AMOUNT.**

4 Section 401(b)(2) of the Higher Education Act of  
5 1965 (20 U.S.C. 1070a(b)(2)) is amended—

6 (1) by redesignating subparagraph (B) as sub-  
7 paragraph (C);

8 (2) by striking subparagraph (A) and inserting  
9 the following:

1           “(A) Except as provided in subparagraph (B),  
2 the amount of the Federal Pell Grant for a student  
3 eligible under this part shall be—

4                   “(i) \$7,600 for academic year 2007–2008;

5                   “(ii) \$8,600 for academic year 2008–2009;

6                   “(iii) \$9,600 for academic year 2009–  
7 2010;

8                   “(iv) \$10,600 for academic year 2010–  
9 2011; and

10                  “(v) \$11,600 for academic year 2011–  
11 2012,

12                  less an amount equal to the amount deter-  
13 mined to be the expected family contribu-  
14 tion with respect to that student for that  
15 year.”; and

16           (3) by inserting after subparagraph (A) (as  
17 amended by paragraph (2)) the following:

18           “(B) If the Secretary determines that the in-  
19 crease from one academic year to the next in the  
20 amount of the maximum Federal Pell Grant author-  
21 ized under subparagraph (A) does not increase stu-  
22 dents’ purchasing power (relative to the cost of at-  
23 tendance at an institution of higher education) by  
24 not less than 5 percentage points, then the amount  
25 of the maximum Federal Pell Grant authorized

1       under subparagraph (A) for the academic year for  
2       which the determination is made shall be increased  
3       by an amount sufficient to achieve such a 5 percent-  
4       age point increase.”.
