## A BILL

To authorize National Mall Liberty Fund D.C. to establish a memorial on Federal land in the District of Columbia at Constitution Gardens previously approved to honor free persons and slaves who fought for independence, liberty, and justice for all during the American Revolution.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Liberty Me-  
5 morial Act”.

1 **SEC. 2. FINDING.**

2 Congress finds that the contributions of free persons  
3 and slaves who fought during the American Revolution  
4 were of preeminent historical and lasting significance to  
5 the United States, as required by section 8908(b)(1) of  
6 title 40, United States Code.

7 **SEC. 3. THE NATIONAL LIBERTY MEMORIAL.**

8 Public Law 99–558 (40 U.S.C. 8903 note; 100 Stat.  
9 3144) is amended—

10 (1) in section 1—

11 (A) in the first sentence—

12 (i) by striking “The Black Revolu-  
13 tionary War Patriots Foundation is au-  
14 thorized to establish a memorial” and in-  
15 serting the following—

16 “(a) IN GENERAL.—National Mall Liberty Fund  
17 D.C. may establish a memorial (referred to in this Act  
18 as the ‘memorial’); and

19 (ii) by striking “Federal land in the  
20 District of Columbia and its environs” and  
21 inserting “the Federal land in the District  
22 of Columbia described in subsection (b)”;  
23 and

24 (B) by striking the second sentence and in-  
25 serting the following:

1       “(b) DESCRIPTION OF LAND.—The Federal land re-  
2       ferred to in subsection (a) is the portion of land at Con-  
3       stitution Gardens, located on the south side of Constitu-  
4       tion Lake and west of the island, that was previously se-  
5       lected as the site for the memorial.

6       “(c) APPLICABLE LAW.—The memorial shall be es-  
7       tablished in accordance with chapter 89 of title 40, United  
8       States Code.”; and

9               (2) in section 2, by striking “The Black Revolu-  
10       tionary War Patriots Foundation” and inserting  
11       “National Mall Liberty Fund D.C.”.
