A BILL

To amend the National Underground Railroad Network to Freedom Act of 1998 to provide additional staff and oversight of funds to carry out the Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Underground
5 Railroad Network to Freedom Reauthorization Act of
6 2007”.

1 **SEC. 2. HIRING STAFF FOR THE NATIONAL UNDERGROUND**
 2 **RAILROAD NETWORK.**

3 Section 3 of the National Underground Railroad Net-
 4 work to Freedom Act of 1998 (16 U.S.C. 469l–1) is
 5 amended by striking subsection (d) and inserting the fol-
 6 lowing:

7 “(d) STAFF.—The Secretary shall appoint at least 8
 8 full-time equivalent staff to assist the Secretary in car-
 9 rying out duties under this Act, including providing over-
 10 sight of the grant program established under section 4.”.

11 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

12 The National Underground Railroad Network to
 13 Freedom Act of 1998 (16 U.S.C. 469l et seq.) is amend-
 14 ed—

15 (1) in section 4 (16 U.S.C. 469l–2), by striking
 16 subsection (d); and

17 (2) by adding at the end the following:

18 **“SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

19 “(a) IN GENERAL.—There is authorized to be appro-
 20 priated for each fiscal year to carry out this Act
 21 \$2,500,000.

22 “(b) ALLOCATION.—Of the amounts made available
 23 under subsection (a)—

24 “(1) \$2,000,000 shall be allocated to carry out
 25 section 3; and

1 “(2) \$500,000 shall be allocated to carry out
2 section 4.

3 “(c) **LIMITATION.**—Any amounts made available
4 under this section shall be made available only to the Sec-
5 retary to carry out the responsibilities of the Secretary
6 under this Act.

7 “(d) **AVAILABILITY.**—Amounts made available under
8 this section shall remain available until expended.”.

9 **SEC. 4. EFFECTIVE DATE.**

10 The amendments made by sections 2 and 3 shall take
11 effect at the beginning of the next fiscal year after the
12 date of enactment of this Act.
