Mr. HASTINGS of Florida (for himself, Ms. CASTOR, Mr. MEEK of Florida, and Ms. WASSERMAN SCHULTZ) introduced the following bill; which was referred to the Committee on House Administration

A BILL

To provide for a rotating schedule for regional selection of delegates to a national Presidential nominating convention, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Regional Presidential
5 Primary and Caucus Act of 2007”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) CAUCUS.—The term “caucus” means any
9 convention, meeting, or series of meetings held for

1 the selection of delegates to a national Presidential
2 nominating convention of a political party.

3 (2) ELECTION YEAR.—The term “election year”
4 means a year during which a Presidential election is
5 to be held.

6 (3) NATIONAL COMMITTEE.—The term “na-
7 tional committee” means the organization which, by
8 virtue of the bylaws of a political party, is respon-
9 sible for the day-to-day operation of such political
10 party at the national level, as determined by the
11 Federal Election Commission.

12 (4) POLITICAL PARTY.—The term “political
13 party” means an association, committee, or organi-
14 zation which—

15 (A) nominates a candidate for election to
16 any Federal office whose name appears on the
17 election ballot as the candidate of such associa-
18 tion, committee, or organization; and

19 (B) won electoral votes in the preceding
20 Presidential election.

21 (5) PRIMARY.—The term “primary” means a
22 primary election held for the selection of delegates to
23 a national Presidential nominating convention of a
24 political party, but does not include a caucus, con-
25 vention, or other indirect means of selection.

1 **SEC. 3. SCHEDULE.**

2 (a) SCHEDULE.—

3 (1) FIRST ELECTION CYCLE.—

4 (A) LOTTERY.—The Election Assistance
5 Commission shall establish procedures for the
6 conduct of a lottery by not later than March 1,
7 2010, to select which of the 4 regions described
8 in subsection (b) will hold the first primary in
9 accordance with the schedule under subpara-
10 graph (B). Based on such selection, the pri-
11 maries shall be conducted in the following
12 order:

13 (i) In the case where Region I is se-
14 lected to hold the first primary—

15 (I) Region II shall hold the sec-
16 ond primary;

17 (II) Region III shall hold the
18 third primary; and

19 (III) Region IV shall hold the
20 fourth primary.

21 (ii) In the case where Region II is se-
22 lected to hold the first primary—

23 (I) Region III shall hold the sec-
24 ond primary;

25 (II) Region IV shall hold the
26 third primary; and

1 (III) Region I shall hold the
2 fourth primary.

3 (iii) In the case where Region III is
4 selected to hold the first primary—

5 (I) Region IV shall hold the sec-
6 ond primary;

7 (II) Region I shall hold the third
8 primary; and

9 (III) Region II shall hold the
10 fourth primary.

11 (iv) In the case where Region IV is se-
12 lected to hold the first primary—

13 (I) Region I shall hold the second
14 primary;

15 (II) Region II shall hold the
16 third primary; and

17 (III) Region III shall hold the
18 fourth primary.

19 (B) SCHEDULE.—Subject to paragraph
20 (3), in 2012, each State that elects to hold a
21 primary shall hold a primary in accordance with
22 this Act, according to the following schedule:

23 (i) FIRST PRIMARY.—Each such State
24 in the region selected to hold the first pri-
25 mary under subparagraph (A) shall hold a

1 primary during the period beginning on
2 the first Tuesday in March and ending on
3 the sixth day following such Tuesday.

4 (ii) SECOND PRIMARY.—Each such
5 State in the region required to hold the
6 second primary under subparagraph (A)
7 shall hold a primary during the period be-
8 ginning on the first Tuesday in April and
9 ending on the sixth day following such
10 Tuesday.

11 (iii) THIRD PRIMARY.—Each such
12 State in the region required to hold the
13 third primary under subparagraph (A)
14 shall hold a primary during the period be-
15 ginning on the first Tuesday in May and
16 ending on the sixth day following such
17 Tuesday.

18 (iv) FOURTH PRIMARY.—Each such
19 State in the region required to hold the
20 fourth primary under subparagraph (A)
21 shall hold a primary during the period be-
22 ginning on the first Tuesday in June and
23 ending on the sixth day following such
24 Tuesday.

25 (2) SUBSEQUENT ELECTION CYCLES.—

1 (A) GENERAL RULE.—Subject to para-
2 graph (3), except as provided in subparagraph
3 (B), in each subsequent election year after
4 2012, each State in each region that elects to
5 hold a primary shall hold a primary during the
6 period beginning on the first Tuesday of the
7 month following the month in which the State
8 held a primary in the preceding election year
9 (or, in the case where the State did not elect to
10 hold a primary in the preceding election year,
11 the month in which the State would have held
12 a primary if it had elected to do so) and ending
13 on the sixth day following such Tuesday.

14 (B) LIMITATION.—If the States in a re-
15 gion were required to hold primaries during the
16 period beginning on the first Tuesday in June
17 of the preceding election year and ending on the
18 sixth day following such Tuesday, the States in
19 such region that elect to hold a primary shall
20 hold a primary during the period beginning on
21 the first Tuesday in March of the succeeding
22 election year and ending on the sixth day fol-
23 lowing such Tuesday.

24 (3) EXCEPTION.—The States described in para-
25 graphs (1)(G) and (3)(C) of subsection (b) may hold

1 a primary on a date prior to the beginning of the
2 period described in paragraph (1)(B)(i). In the case
3 where such a State does not elect to hold a primary
4 prior to the beginning of such period, if the State
5 elects to hold a primary, the State shall hold a pri-
6 mary during the period in which the region the State
7 is in (as determined under subsection (b)) is sched-
8 uled to hold a primary (as determined under para-
9 graphs (1) and (2)).

10 (b) REGIONS.—For purposes of subsection (a):

11 (1) REGION I.—Region I shall be comprised of
12 the following:

13 (A) Connecticut.

14 (B) Delaware.

15 (C) District of Columbia.

16 (D) Maine.

17 (E) Maryland.

18 (F) Massachusetts.

19 (G) New Hampshire.

20 (H) New Jersey.

21 (I) New York.

22 (J) Pennsylvania.

23 (K) Rhode Island.

24 (L) Vermont.

25 (M) West Virginia.

1 (2) REGION II.—Region II shall be comprised of
2 the following:

- 3 (A) Alabama.
- 4 (B) Arkansas.
- 5 (C) Florida.
- 6 (D) Georgia.
- 7 (E) Kentucky.
- 8 (F) Louisiana.
- 9 (G) Mississippi.
- 10 (H) North Carolina.
- 11 (I) Oklahoma.
- 12 (J) South Carolina.
- 13 (K) Tennessee.
- 14 (L) Texas.
- 15 (M) Virginia.

16 (3) REGION III.—Region III shall be comprised
17 of the following:

- 18 (A) Illinois.
- 19 (B) Indiana.

- 21 (D) Kansas.
- 22 (E) Michigan.
- 23 (F) Minnesota.
- 24 (G) Missouri.
- 25 (H) Nebraska.

1 (I) North Dakota.

2 (J) Ohio.

4 (L) Wisconsin.

5 (4) REGION IV.—Region IV shall be comprised
6 of the following:

7 (A) Alaska.

8 (B) Arizona.

9 (C) California.

10 (D) Colorado.

11 (E) Hawaii.

12 (F) Idaho.

13 (G) Montana.

14 (H) Nevada.

15 (I) New Mexico.

16 (J) Oregon.

17 (K) Utah.

18 (L) Washington.

19 (M) Wyoming.

20 (5) TERRITORIES.—The national committees
21 shall jointly determine the region of each territory of
22 the United States.

23 **SEC. 4. STATE CAUCUS TO SELECT DELEGATES.**

24 (a) IN GENERAL.—Subject to subsection (b), in the
25 case where a State elects to select delegates to a national

1 Presidential nominating convention of a political party
2 through a caucus held by any political party which has
3 the authority to nominate a candidate, the State shall hold
4 a caucus during the period in which the region the State
5 is in (as determined under section 3(b)) is scheduled to
6 hold a primary (as determined under paragraphs (1) and
7 (2) of section 3(a)).

8 (b) EXCEPTION.—The States described in para-
9 graphs (1)(G) and (3)(C) of section 3(b) may hold a cau-
10 cus on a date prior to the beginning of the period de-
11 scribed in section 3(a)(1)(B)(i). In the case where such
12 a State does not elect to hold a caucus prior to the begin-
13 ning of such period, if the State elects to hold a caucus,
14 the State shall hold a caucus during the period in which
15 the region the State is in (as determined under section
16 3(b)) is scheduled to hold a primary (as determined under
17 paragraphs (1) and (2) of section 3(a)).

18 **SEC. 5. RULE OF CONSTRUCTION.**

19 Nothing in this Act—

20 (1) shall be construed as requiring a State to
21 hold a primary or a caucus for the selection of dele-
22 gates to a national Presidential nominating conven-
23 tion of a political party; or

24 (2) is intended to confer to the Election Assist-
25 ance Commission any power concerning the selection

1 of delegates other than that expressly provided
2 under section 3(a)(1)(A).

3 **SEC. 6. EFFECTIVE DATE.**

4 This Act shall apply with respect to any primary or
5 caucus held in connection with a general election held in
6 the year 2012 and in each election year thereafter.
