## A BILL

To amend the Federal Water Pollution Control Act relating to recreational vessels.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Recreational Boating  
5 Act of 2007”.

6 **SEC. 2. DEFINITIONS.**

7 (a) POLLUTANT.—Section 502(6) of the Federal  
8 Water Pollution Control Act (33 U.S.C. 1362(6)) is  
9 amended—

1 (1) by striking “(6) The term ‘pollutant’” and  
2 inserting the following:

3 “(6) POLLUTANT.—

4 “(A) IN GENERAL.—The term ‘pollutant’”;

5 and

6 (2) in the second sentence—

7 (A) by striking “This term does not mean”

8 and inserting the following:

9 “(B) EXCEPTIONS.—

10 “(i) IN GENERAL.—Subject to clause

11 (ii), the term ‘pollutant’ does not mean”;

12 (B) by striking “(A) sewage” and inserting

13 the following:

14 “(I) sewage”;

15 (C) by striking “or (B) water” and insert-

16 ing the following:

17 “(II) water”;

18 (D) by striking the period at the end and

19 inserting “; or”; and

20 (E) by adding at the end the following:

21 “(II) any deck runoff from a rec-

22 reational vessel, any engine cooling

23 water, gray water, bilge water effluent

24 from properly functioning recreational

25 marine engine, laundry, shower, and

1 galley sink waste from a recreational  
2 vessel, or any other discharge inci-  
3 dental to the normal operation of a  
4 recreational vessel.

5 “(ii) EXCEPTION.—Clause (i)(III)  
6 does not apply to rubbish, trash, garbage,  
7 or any other similar material discharged  
8 overboard by a recreational vessel.”.

9 (b) RECREATIONAL VESSEL.—Section 502 of the  
10 Federal Water Pollution Control Act (33 U.S.C. 1362) is  
11 amended by adding at the end the following:

12 “(25) RECREATIONAL VESSEL.—The term ‘rec-  
13 reational vessel’ means a vessel that is—

14 “(A) manufactured for operation, or oper-  
15 ated, primarily for recreational purposes; or

16 “(B) leased, rented, or chartered to an in-  
17 dividual for recreational purposes.”.
