## A BILL

To extend the trade adjustment assistance program under the Trade Act of 1974 for 3 months.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TEMPORARY EXTENSION OF TRADE ADJUST-**  
4 **MENT ASSISTANCE PROGRAM.**

5 (a) ASSISTANCE FOR WORKERS.—Section 245(a) of  
6 the Trade Act of 1974 (19 U.S.C. 2317(a)) is amended  
7 by striking “December 31, 2007” and inserting “March  
8 31, 2008”.

9 (b) ASSISTANCE FOR FIRMS.—Section 256(b) of the  
10 Trade Act of 1974 (19 U.S.C. 2346(b)) is amended—

1           (1) by striking “and \$4,000,000” and inserting  
2           “\$4,000,000”; and

3           (2) by inserting after “October 1, 2007,” the  
4           following: “and \$4,000,000 for the 3-month period  
5           beginning on January 1, 2008,”.

6           (c) ASSISTANCE FOR FARMERS.—Section 298(a) of  
7           the Trade Act of 1974 (19 U.S.C. 2401g(a)) is amend-  
8           ed—

9           (1) by striking “, and there are authorized”  
10           and inserting “. There are authorized”; and

11           (2) by adding at the end the following: “There  
12           are authorized to be appropriated and there are ap-  
13           propriated to the Department of Agriculture to carry  
14           out this chapter \$9,000,000 for the 3-month period  
15           beginning on January 1, 2008.”.

16           (d) EXTENSION OF TERMINATION DATES.—Section  
17           285 of the Trade Act of 1974 (19 U.S.C. 2271 note) is  
18           amended by striking “December 31, 2007” each place it  
19           appears and inserting “March 31, 2008”.

20           (e) EFFECTIVE DATE.—The amendments made by  
21           subsections (a) through (d) shall be effective as of January  
22           1, 2008.

23           **SEC. 2. OFFSETS.**

24           (a) TIME FOR PAYMENT OF CORPORATE ESTIMATED  
25           TAXES.—The percentage under subparagraph (B) of sec-

1 tion 401(1) of the Tax Increase Prevention and Reconcili-  
2 ation Act of 2005 in effect on the date of the enactment  
3 of this Act is increased by 0.25 percentage points.

4 (b) CUSTOMS USER FEES.—Section  
5 13031(j)(3)(B)(i) of the Consolidated Omnibus Budget  
6 Reconciliation Act of 1985 (19 U.S.C. 58c(j)(3)(B)(i)) is  
7 amended by striking “December 13, 2014” and inserting  
8 “December 20, 2014”.
