## AN ACT

To extend the trade adjustment assistance program under  
the Trade Act of 1974 for 3 months.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. TEMPORARY EXTENSION OF TRADE ADJUST-**  
2 **MENT ASSISTANCE PROGRAM.**

3 (a) ASSISTANCE FOR WORKERS.—Section 245(a) of  
4 the Trade Act of 1974 (19 U.S.C. 2317(a)) is amended  
5 by striking “December 31, 2007” and inserting “March  
6 31, 2008”.

7 (b) ASSISTANCE FOR FIRMS.—Section 256(b) of the  
8 Trade Act of 1974 (19 U.S.C. 2346(b)) is amended—

9 (1) by striking “and \$4,000,000” and inserting  
10 “\$4,000,000”; and

11 (2) by inserting after “October 1, 2007,” the  
12 following: “and \$4,000,000 for the 3-month period  
13 beginning on January 1, 2008,”.

14 (c) ASSISTANCE FOR FARMERS.—Section 298(a) of  
15 the Trade Act of 1974 (19 U.S.C. 2401g(a)) is amend-  
16 ed—

17 (1) by striking “, and there are authorized”  
18 and inserting “. There are authorized”; and

19 (2) by adding at the end the following: “There  
20 are authorized to be appropriated and there are ap-  
21 propriated to the Department of Agriculture to carry  
22 out this chapter \$9,000,000 for the 3-month period  
23 beginning on January 1, 2008.”.

24 (d) EXTENSION OF TERMINATION DATES.—Section  
25 285 of the Trade Act of 1974 (19 U.S.C. 2271 note) is

1 amended by striking “December 31, 2007” each place it  
2 appears and inserting “March 31, 2008”.

3 (e) EFFECTIVE DATE.—The amendments made by  
4 subsections (a) through (d) shall be effective as of January  
5 1, 2008.

6 **SEC. 2. OFFSETS.**

7 (a) TIME FOR PAYMENT OF CORPORATE ESTIMATED  
8 TAXES.—The percentage under subparagraph (B) of sec-  
9 tion 401(1) of the Tax Increase Prevention and Reconcili-  
10 ation Act of 2005 in effect on the date of the enactment  
11 of this Act is increased by 0.25 percentage points.

12 (b) CUSTOMS USER FEES.—Section  
13 13031(j)(3)(B)(i) of the Consolidated Omnibus Budget  
14 Reconciliation Act of 1985 (19 U.S.C. 58c(j)(3)(B)(i)) is  
15 amended by striking “December 13, 2014” and inserting  
16 “December 20, 2014”.
