A BILL

To require the Secretary of Homeland Security to complete at least 700 miles of reinforced fencing along the Southwest border by December 31, 2010, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Complete the Fence
5 Act”.

1 **SEC. 2. EXTENSION OF REINFORCED FENCING ALONG**
2 **SOUTHWEST BORDER.**

3 Section 102(b)(1) of the Illegal Immigration Reform
4 and Immigrant Responsibility Act of 1996 (8 U.S.C. 1103
5 note) is amended—

6 (1) in subparagraph (A), by adding at the end
7 the following: “Fencing that does not effectively re-
8 strain pedestrian traffic (such as vehicle barriers
9 and virtual fencing) may not be used to meet the
10 700-mile fence requirement under this subpara-
11 graph.”;

12 (2) in subparagraph (B)—

13 (A) in clause (i), by striking “and” at the
14 end;

15 (B) in clause (ii), by striking the period at
16 the end and inserting “; and”; and

17 (C) by adding at the end the following:

18 “(iii) not later than December 31,
19 2010, complete the construction of all the
20 reinforced fencing and the installation of
21 the related equipment described in sub-
22 paragraph (A).”; and

23 (3) in subparagraph (C), by adding at the end
24 the following:

25 “(iii) **FUNDING NOT CONTINGENT ON**
26 **CONSULTATION.**—Amounts appropriated to

1 carry out this paragraph may not be im-
2 pounded or otherwise withheld for failure
3 to fully comply with the consultation re-
4 quirement under clause (i).”.

5 **SEC. 3. PROGRESS REPORT.**

6 Not later than June 30, 2009, the Secretary of
7 Homeland Security shall submit a report to Congress that
8 describes—

9 (1) the progress made in completing the rein-
10 forced fencing required under section 102(b)(1) of
11 the Illegal Immigration Reform and Immigrant Re-
12 sponsibility Act of 1996 (8 U.S.C. 1103 note), as
13 amended by this Act; and

14 (2) the plans for completing such fencing before
15 December 31, 2010.
