3.22 This appropriation is to pay for Greater

3.25 Session chapter 6, article 1, section 2,
3.26 subdivision 2, paragraph (b). This is a
3.27 onetime appropriation.

3.28 **Sec. 9. METROPOLITAN COUNCIL** **\$** **7,847,000**

3.29 This appropriation is to pay for bus system
3.30 operations and is added to appropriations in
3.31 Laws 2005, First Special Session chapter 6,
3.32 article 1, section 3, paragraph (a). This is a
3.33 onetime appropriation.

4.10 **Sec. 11. FINANCE** **\$** **240,000**

4.11 The commissioner of finance shall pay this
4.12 amount to the court administrator of the
4.13 Fourth Judicial District for distribution
4.14 according to Minnesota Statutes 2004,
4.15 section 488A.03, subdivision 9. This
4.16 appropriation replaces funding lost in fiscal
4.17 year 2007 due to the inadvertent repeal
4.18 of Minnesota Statutes, section 488A.03,
4.19 subdivision 9, in Laws 2006, chapter 260,
4.20 article 5, section 54. This is a onetime
4.21 appropriation.

4.22 **Sec. 12. EFFECTIVE DATE.**

4.23 This act is effective the day following final enactment.
