1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2007 Supplement, section 240.18, subdivision 4, is
1.10 amended to read:

1.11 Subd. 4. **Rules; advisory committees.** The commission shall adopt rules governing
1.12 the distribution of the fund. The commission may establish advisory committees to
1.13 advise it on the distribution of money under this section, provided that the members of an
1.14 advisory committee shall serve without compensation. The expiration date provided in
1.15 section 15.059, subdivision 5, does not apply to this subdivision.

1.16 **EFFECTIVE DATE.** This section is effective retroactively from August 1, 2007.

1.18 to read:

1.19 Subd. 4c. **Duration of peer review committee.** The peer review committee under
1.20 subdivision 4b does not expire and the expiration date provided in section 15.059,
