ETHICS/BOARD OR NO IMPACT GF EX See Note Page 1 of 1
 Provides relative to procedures of the Board of Ethics (Items #4(5), (6), (7), and (10))

Provides for confidential advisory opinions from the Board of Ethics. Requires the board to determine whether to conduct a hearing within 45 days of receiving a complaint. Prohibits a member who makes a motion to investigate an anonymous complaint from participating in any subsequent hearing. Requires the board to offer confidential consent opinions. Provides procedures for waiver and reduction of late filing fees.
