STUDENT/TUITION: Authorizes the Univ. of La. System Bd. of Supervisors to impose an increase in tuition and mandatory attendance fee amounts for students attending the Univ. of La. at Lafayette

1 AN ACT

2 To enact R.S. 17:3351.13, to authorize the Board of Supervisors for the University of
3 Louisiana System to impose an increase in tuition and mandatory attendance fee
4 amounts for students attending the University of Louisiana at Lafayette; to specify
5 the amount of such increase; to provide for effectiveness; and to provide for related
6 matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 17:3351.13 is hereby enacted to read as follows:

9 §3351.13. Tuition and attendance fee amounts; University of Louisiana at Lafayette

10 In addition to the authority granted to the Board of Supervisors for the
11 University of Louisiana System by R.S. 17:3351(A)(5) and in accordance with
12 Article VII, Section 2.1(A) of the Constitution of Louisiana, the board may impose
13 an increase in tuition and mandatory attendance fee amounts by not more than four
14 percent for students attending the University of Louisiana at Lafayette effective for
15 the Fall 2008 semester and thereafter.

16 Section 2. This Act shall become effective upon signature by the governor or, if not
17 signed by the governor, upon expiration of the time for bills to become law without signature
18 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

- 1 vetoed by the governor and subsequently approved by the legislature, this Act shall become
2 effective on the day following such approval.

Abstract: Authorizes the Bd. of Supervisors for the Univ. of La. System to impose an increase in tuition and mandatory attendance fee amounts by not more than 4% for students attending the Univ. of La. at Lafayette effective for Fall, 2008 and thereafter.

Proposed law authorizes the Bd. of Supervisors for the Univ. of La. System to impose an increase in tuition and mandatory attendance fee amounts by not more than 4% for students attending the Univ. of La. at Lafayette effective for the Fall, 2008, semester and thereafter. Specifies that such increase shall be in addition to present law authority of postsecondary education management boards to determine the fees to be paid by students and shall be accordance with present constitution that requires that any new fee or increase in an existing fee imposed by the state or any state board, department, or agency be enacted by a 2/3 vote of each house of the legislature.

Effective upon signature of governor or lapse of time for gubernatorial action.
