## AN ACT

To make technical corrections regarding the Newborn  
Screening Saves Lives Act of 2007.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. TECHNICAL CORRECTION TO NEWBORN**  
2 **SCREENING SAVES LIVES ACT.**

3 (a) AMENDMENTS TO THE PUBLIC HEALTH SERVICE  
4 ACT.—

5 (1) IMPROVED SCREENING.—Section 1109 of  
6 the Public Health Service Act (42 U.S.C. 300b–  
7 8(j)), as added by section 2 of the Newborn Screen-  
8 ing Saves Lives Act of 2007, is amended by striking  
9 subsection (j) and inserting the following:

10 “(j) AUTHORIZATION OF APPROPRIATIONS.—There  
11 are authorized to be appropriated—

12 “(1) to provide grants for the purpose of car-  
13 rying out activities under subsection (a)(1),  
14 \$15,000,000 for fiscal year 2009; \$15,187,500 for  
15 fiscal year 2010, \$15,375,000 for fiscal year 2011,  
16 \$15,562,500 for fiscal year 2012, and \$15,750,000  
17 for fiscal year 2013; and

18 “(2) to provide grants for the purpose of car-  
19 rying out activities under paragraphs (2), (3), and  
20 (4) of subsection (a), \$15,000,000 for fiscal year  
21 2009, \$15,187,500 for fiscal year 2010,  
22 \$15,375,000 for fiscal year 2011, \$15,562,500 for  
23 fiscal year 2012, and \$15,750,000 for fiscal year  
24 2013.”.

25 (2) EVALUATING THE EFFECTIVENESS.—Sec-  
26 tion 1110(d) of the Public Health Service Act (42

1 U.S.C. 300b–9(d)), as added by section 3 of the  
2 Newborn Screening Saves Lives Act of 2007, is  
3 amended by striking “2008” and all that follows and  
4 inserting “2009, \$5,062,500 for fiscal year 2010,  
5 \$5,125,000 for fiscal year 2011, \$5,187,500 for fis-  
6 cal year 2012, and \$5,250,000 for fiscal year  
7 2013.”.

8 (3) ADVISORY COMMITTEE.—Section 1111 of  
9 the Public Health Service Act (42 U.S.C. 300b–11),  
10 as amended by section 4 of the Newborn Screening  
11 Saves Lives Act of 2007, is amended—

12 (A) in subsection (d)(2), by striking  
13 “2007” and inserting “2008”;

14 (B) in subsection (e), by striking “2007”  
15 and inserting “2008”;

16 (C) in subsection (f), by striking “2007”  
17 and inserting “2008”; and

18 (D) in subsection (g), by striking “2008”  
19 and all that follows and inserting “2009,  
20 \$1,012,500 for fiscal year 2010, \$1,025,000 for  
21 fiscal year 2011, \$1,037,500 for fiscal year  
22 2012, and \$1,050,000 for fiscal year 2013.”.

23 (4) CLEARINGHOUSE.—Section 1112 of the  
24 Public Health Service Act (as added by section 5 of

1 the Newborn Screening Saves Lives Act of 2007) is  
2 amended—

3 (A) in subsection (b)(4)(D), by striking  
4 “2007” and inserting “2008”; and

5 (B) in subsection (d), by striking “2008”  
6 and all that follows and inserting “2009,  
7 \$2,531,250 for fiscal year 2010, \$2,562,500 for  
8 fiscal year 2011, \$2,593,750 for fiscal year  
9 2012, and \$2,625,000 for fiscal year 2013.”.

10 (5) LABORATORY QUALITY.—Section 1113(b) of  
11 the Public Health Service Act (as added by section  
12 6 of the Newborn Screening Saves Lives Act of  
13 2007) is amended by striking “2008” and all that  
14 follows and inserting “2009, \$5,062,500 for fiscal  
15 year 2010, \$5,125,000 for fiscal year 2011,  
16 \$5,187,500 for fiscal year 2012, and \$5,250,000 for  
17 fiscal year 2013.”.

18 (6) INTERAGENCY COORDINATING COM-  
19 MITTEE.—Section 1114(e) of the Public Health  
20 Service Act (as added by section 6 of the Newborn  
21 Screening Saves Lives Act of 2007) is amended by  
22 striking “2008” and all that follows and inserting  
23 “2009, \$1,012,500 for fiscal year 2010, \$1,025,000  
24 for fiscal year 2011, \$1,037,500 for fiscal year  
25 2012, and \$1,050,000 for fiscal year 2013.”.

1           (7) HUNTER KELLY RESEARCH PROGRAM.—  
2           Section 1116(a)(1)(B) of the Public Health Service  
3           Act (as added by section 7 of the Newborn Screen-  
4           ing Saves Lives Act of 2007) is amended by striking  
5           “and or” and inserting “, or”.

6           (b) OTHER TECHNICAL AMENDMENTS.—The New-  
7           born Screening Saves Lives Act of 2007 is amended—

8           (1) in section 1, by striking “2007” and insert-  
9           ing “2008”; and

10          (2) in section 4(2)(A), by inserting “, respec-  
11          tively” before the semicolon.
