## A BILL

To establish a program for providing scholarships for nuclear science and nuclear engineering students, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. NUCLEAR SCIENCE AND ENGINEERING SCHOL-**  
4 **ARSHIPS.**

5 (a) PURPOSE.—It is the purpose of this section to  
6 authorize scholarships funded by the Department of En-

1 ergy for undergraduate education in nuclear science and  
2 nuclear engineering.

3 (b) SCHOLARSHIP PROGRAM AUTHORIZED.—

4 (1) IN GENERAL.—The Secretary of Energy  
5 shall award not less than 65 grants per year to eligi-  
6 ble undergraduate institutions to support scholar-  
7 ships for students majoring in nuclear science or nu-  
8 clear engineering.

9 (2) APPLICATION.—An eligible undergraduate  
10 institution that desires to receive a grant under this  
11 section shall submit to the Secretary of Energy an  
12 application at such time, in such manner, and ac-  
13 companied by such information as the Secretary may  
14 require.

15 (3) DURATION AND AMOUNT.—A grant under  
16 this section shall be 4 years in duration. An eligible  
17 undergraduate institution that receives a grant  
18 under this section shall receive \$100,000 for each  
19 year of the grant period.

20 (4) USE OF FUNDS.—An eligible undergraduate  
21 institution that receives a grant under this section  
22 shall use the grant funds for the awarding of schol-  
23 arships in nuclear science or nuclear engineering.

24 (5) AUTHORIZATION OF APPROPRIATIONS.—  
25 There are authorized to be appropriated to carry out

1       this section \$6,500,000 for each of the fiscal years  
2       2009 through 2013.

3 **SEC. 2. NUCLEAR WORKFORCE DEVELOPMENT.**

4       Not later than 120 days after the date of enactment  
5 of this Act, the Secretary of Energy, in consultation with  
6 the Secretary of Labor, shall provide to Congress rec-  
7 ommendations for developing a robust nuclear workforce  
8 within the United States.
