CONCURRENT RESOLUTION

To make technical corrections in the enrollment of the bill
S. 1858.

1 *Resolved by the Senate (the House of Representatives*
2 *concurring)*, That in the enrollment of the bill S. 1858
3 (to amend the Public Health Service Act to establish grant
4 programs to provide for education and outreach on new-
5 born screening and coordinated followup care once new-
6 born screening has been conducted, to reauthorize pro-
7 grams under part A of title XI of such Act, and for other
8 purposes) the Secretary of the Senate shall make the fol-
9 lowing technical corrections:

10 (1) In section 1, strike “2007” and insert
11 “2008”.

1 (2) In section 1109 of the Public Health Serv-
2 ice Act (as amended by section 2) strike subsection
3 (j) and insert the following:

4 “(j) AUTHORIZATION OF APPROPRIATIONS.—There
5 are authorized to be appropriated—

6 “(1) to provide grants for the purpose of car-
7 rying out activities under subsection (a)(1),
8 \$15,000,000 for fiscal year 2009; \$15,187,500 for
9 fiscal year 2010, \$15,375,000 for fiscal year 2011,
10 \$15,562,500 for fiscal year 2012, and \$15,750,000
11 for fiscal year 2013; and

12 “(2) to provide grants for the purpose of car-
13 rying out activities under paragraphs (2), (3), and
14 (4) of subsection (a), \$15,000,000 for fiscal year
15 2009, \$15,187,500 for fiscal year 2010,
16 \$15,375,000 for fiscal year 2011, \$15,562,500 for
17 fiscal year 2012, and \$15,750,000 for fiscal year
18 2013.”.

19 (3) In section 1110(d) of the Public Health
20 Service Act (as added by section 3), strike “2008”
21 and all that follows and insert “2009, \$5,062,500
22 for fiscal year 2010, \$5,125,000 for fiscal year
23 2011, \$5,187,500 for fiscal year 2012, and
24 \$5,250,000 for fiscal year 2013.”.

1 (4) In section 4(2)(A), insert “, respectively”
2 before the semicolon.

3 (5) In section 1111 of the Public Health Serv-
4 ice Act (as amended by section 4)—

5 (A) in subsection (d)(2), strike “2007”
6 and insert “2008”;

7 (B) in subsection (e), strike “2007” and
8 insert “2008”;

9 (C) in subsection (f), strike “2007” and
10 insert “2008”; and

11 (D) in subsection (g), strike “2008” and
12 all that follows and insert “2009, \$1,012,500
13 for fiscal year 2010, \$1,025,000 for fiscal year
14 2011, \$1,037,500 for fiscal year 2012, and
15 \$1,050,000 for fiscal year 2013.”.

16 (6) In section 1112 of the Public Health Serv-
17 ice Act (as added by section 5)—

18 (A) in subsection (b)(4)(D), strike “2007”
19 and insert “2008”; and

20 (B) in subsection (d), strike “2008” and
21 all that follows and insert “2009, \$2,531,250
22 for fiscal year 2010, \$2,562,500 for fiscal year
23 2011, \$2,593,750 for fiscal year 2012, and
24 \$2,625,000 for fiscal year 2013.”.

1 (7) In section 1113(b) of the Public Health
2 Service Act (as added by section 6), strike “2008”
3 and all that follows and insert “2009, \$5,062,500
4 for fiscal year 2010, \$5,125,000 for fiscal year
5 2011, \$5,187,500 for fiscal year 2012, and
6 \$5,250,000 for fiscal year 2013.”.

7 (8) In section 1114(e) of the Public Health
8 Service Act (as added by section 6), strike “2008”
9 and all that follows and insert “2009, \$1,012,500
10 for fiscal year 2010, \$1,025,000 for fiscal year
11 2011, \$1,037,500 for fiscal year 2012, and
12 \$1,050,000 for fiscal year 2013.”.

13 (9) In section 1116(a)(1)(B) of the Public
14 Health Service Act (as added by section 7) strike
15 “and or” and insert “, or”.
