## CONCURRENT RESOLUTION

1        *Resolved by the House of Representatives (the Senate*  
2 *concurring),*

3        **SECTION 1. AUTHORIZATION OF SOAP BOX DERBY RACES**

4                                **ON CAPITOL GROUNDS.**

5        The Greater Washington Soap Box Derby Associa-  
6 tion (in this resolution referred to as the “Association”)  
7 shall be permitted to sponsor a public event, soap box

1 derby races, on the Capitol Grounds on June 21, 2008,  
2 or on such other date as the Speaker of the House of Rep-  
3 resentatives and the Committee on Rules and Administra-  
4 tion of the Senate may jointly designate.

5 **SEC. 2. CONDITIONS.**

6       The event to be carried out under this resolution shall  
7 be free of admission charge to the public and arranged  
8 not to interfere with the needs of Congress, under condi-  
9 tions to be prescribed by the Architect of the Capitol and  
10 the Capitol Police Board; except that the Association shall  
11 assume full responsibility for all expenses and liabilities  
12 incident to all activities associated with the event.

13 **SEC. 3. STRUCTURES AND EQUIPMENT.**

14       For the purposes of this resolution, the Association  
15 is authorized to erect upon the Capitol Grounds, subject  
16 to the approval of the Architect of the Capitol, such stage,  
17 sound amplification devices, and other related structures  
18 and equipment as may be required for the event to be car-  
19 ried out under this resolution.

20 **SEC. 4. ADDITIONAL ARRANGEMENTS.**

21       The Architect of the Capitol and the Capitol Police  
22 Board are authorized to make any such additional ar-  
23 rangements that may be required to carry out the event  
24 under this resolution.

1 **SEC. 5. ENFORCEMENT OF RESTRICTIONS.**

2       The Capitol Police Board shall provide for enforce-  
3 ment of the restrictions contained in section 5104(c) of  
4 title 40, United States Code, concerning sales, advertise-  
5 ments, displays, and solicitations on the Capitol Grounds,  
6 as well as other restrictions applicable to the Capitol  
7 Grounds, with respect to the event to be carried out under  
8 this resolution.
