Abstract: Abolishes certain inactive boards, commissions, authorities, and like entities, and removes references to certain such abolished entities.

Proposed law repeals and removes references to, provisions for, and the powers, functions, and duties of the following boards, commissions, authorities, and like entities:

Applied Polymer Technology Extension Consortium Advisory Committee & Board of Directors (R.S. 36:109(B) and R.S. 51:971, 973, 974, and 976)

Atchafalaya Trace Heritage Area Development Zone Review Board (R.S. 25:1226.1(7), 1226.2, and 1226.4(B)(1) and R.S. 36:209(M)(3))

Committee on Law Enforcement Services for the Elderly (Ch. 8(A) of Title 15, R.S. 15:1231-1237)

Present law places the Respiratory Care Advisory Committee and the Nursing Supply and Demand Commission within the Dept. of Health and Hospitals (DHH) under the category of licencing agencies.

Proposed law removes the Respiratory Care Advisory Committee and the Nursing Supply and Demand Commission from such category within DHH but keeps them within DHH.
