A BILL

To amend the Wild and Scenic Rivers Act to designate certain rivers and streams of the headwaters of the Snake River System as additions to the National Wild and Scenic Rivers System.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Snake Headwaters
3 Legacy Act of 2007”.

4 **SEC. 2. FINDINGS; PURPOSES.**

5 (a) FINDINGS.—Congress finds that—

6 (1) the headwaters of the Snake River System
7 in northwest Wyoming feature some of the cleanest
8 sources of freshwater, healthiest native trout fish-
9 eries, and most intact rivers and streams in the
10 lower 48 States;

11 (2) the rivers and streams of the headwaters of
12 the Snake River System—

13 (A) provide unparalleled fishing, hunting,
14 boating, and other recreational activities for—

15 (i) local residents; and

16 (ii) millions of visitors from around
17 the world; and

18 (B) are national treasures;

19 (3) each year, recreational activities on the riv-
20 ers and streams of the headwaters of the Snake
21 River System generate millions of dollars for the
22 economies of—

23 (A) Teton County, Wyoming;

24 (B) Lincoln County, Wyoming; and

25 (C) Sublette County, Wyoming;

1 (4) to ensure that future generations of citizens
2 of the United States enjoy the benefits of the rivers
3 and streams of the headwaters of the Snake River
4 System, Congress should apply the protections pro-
5 vided by the Wild and Scenic Rivers Act (16 U.S.C.
6 1271 et seq.) to those rivers and streams; and

7 (5) the designation of the rivers and streams of
8 the headwaters of the Snake River System under the
9 Wild and Scenic Rivers Act (16 U.S.C. 1271 et seq.)
10 will signify to the citizens of the United States the
11 importance of maintaining the outstanding and re-
12 markable qualities of the Snake River System
13 while—

14 (A) preserving public access to those rivers
15 and streams;

16 (B) respecting private property rights (in-
17 cluding existing water rights); and

18 (C) continuing to allow traditional uses of
19 the rivers and streams, including—

20 (i) fishing;

21 (ii) hunting;

22 (iii) camping;

23 (iv) the use of all-terrain vehicles;

24 (v) boating;

25 (vi) snowmobiling;

1 (vii) outfitting; and

2 (viii) livestock grazing.

3 (b) PURPOSES.—The purposes of this Act are—

4 (1) to protect for current and future genera-
5 tions of citizens of the United States the remarkable
6 scenic, natural, wildlife, fishery, recreational, sci-
7 entific, historic, and ecological values of the rivers
8 and streams of the headwaters of the Snake River
9 System; and

10 (2) to designate 442.5 miles of the rivers and
11 streams of the headwaters of the Snake River Sys-
12 tem as additions to the National Wild and Scenic
13 Rivers System.

14 **SEC. 3. DEFINITIONS.**

15 In this Act:

16 (1) SECRETARY CONCERNED.—The term “Sec-
17 retary concerned” means—

18 (A) the Secretary of Agriculture (acting
19 through the Chief of the Forest Service), with
20 respect to each river segment described in para-
21 graph (170) of section 3(a) of the Wild and
22 Scenic Rivers Act (16 U.S.C. 1274(a)) (as
23 added by section 4(4)) that is not located in the
24 Grand Teton National Park; and

1 (B) the Secretary of the Interior, with re-
 2 spect to each river segment described in para-
 3 graph (170) of section 3(a) of the Wild and
 4 Scenic Rivers Act (16 U.S.C. 1274(a)) (as
 5 added by section 4(4)) that is located in the
 6 Grand Teton National Park.

7 (2) STATE.—The term “State” means the State
 8 of Wyoming.

9 **SEC. 4. WILD AND SCENIC RIVER DESIGNATIONS, SNAKE**
 10 **RIVER SYSTEM.**

11 Section 3(a) of the Wild and Scenic Rivers Act (16
 12 U.S.C. 1274(a)) is amended—

13 (1) by redesignating paragraph (167) (relating
 14 to the Musconetcong River, New Jersey) as para-
 15 graph (169);

16 (2) by designating the undesignated paragraph
 17 relating to the White Salmon River, Washington, as
 18 paragraph (167);

19 (3) by designating the undesignated paragraph
 20 relating to the Black Butte River, California, as
 21 paragraph (168); and

22 (4) by adding at the end the following:

23 “(170) WILD AND SCENIC RIVER DESIGNA-
 24 TIONS, SNAKE RIVER SYSTEM.—The following seg-

1 ments of the Snake River System, in the State of
2 Wyoming:

3 “(A) BAILEY CREEK.—The 7-mile segment
4 of Bailey Creek, from the divide with the Little
5 Greys River north to its confluence with the
6 Snake River, as a wild river.

7 “(B) BLACKROCK CREEK.—The 22-mile
8 segment from its source to the Bridger-Teton
9 National Forest boundary, as a scenic river.

10 “(C) BUFFALO FORK OF THE SNAKE
11 RIVER.—The portions of the Buffalo Fork of
12 the Snake River, consisting of—

13 “(i) the 55-mile segment consisting of
14 the North Fork, the Soda Fork, and the
15 South Fork, upstream from Turpin Mead-
16 ows, as a wild river;

17 “(ii) the 14-mile segment from Turpin
18 Meadows to the upstream boundary of
19 Grand Teton National Park, as a scenic
20 river; and

21 “(iii) the 7.7-mile segment from the
22 upstream boundary of Grand Teton Na-
23 tional Park to its confluence with the
24 Snake River, as a scenic river.

1 “(D) CLIFF CREEK.—The portions of Cliff
2 Creek, consisting of—

3 “(i) the 9-mile segment from its
4 source to Cliff Creek Falls trailhead, as a
5 wild river; and

6 “(ii) the lower 8-mile segment to the
7 confluence of the Hoback River, as a see-
8 nie river.

9 “(E) CRYSTAL CREEK.—The portions of
10 Crystal Creek, consisting of—

11 “(i) the 14-mile segment from its
12 source to the Gros Ventre Wilderness
13 boundary, as a wild river; and

14 “(ii) the 5-mile segment from the
15 Gros Ventre Wilderness boundary to its
16 confluence with the Gros Ventre River, as
17 a scenic river.

18 “(F) GRANITE CREEK.—The portions of
19 Granite Creek, consisting of—

20 “(i) the 12-mile segment from its
21 source to the end of Granite Creek Road,
22 as a wild river; and

23 “(ii) the 10.5-mile segment from
24 Granite Hot Springs to its confluence with
25 the Hoback River, as a scenic river.

1 “(G) GROS VENTRE RIVER.—The portions
2 of the Gros Ventre River, consisting of—

3 “(i) the 16.5-mile segment from its
4 source to Darwin Ranch, as a wild river;

5 “(ii) the 39-mile segment from Dar-
6 win Ranch to the upstream boundary of
7 Grand Teton National Park, excluding the
8 section along Lower Slide Lake, as a see-
9 nie river; and

10 “(iii) the 10.8-mile segment flowing
11 across the southern boundary of Grand
12 Teton National Park to the Highway 89
13 bridge, as a scenic river.

14 “(H) HOBACK RIVER.—The portions of the
15 Hoback River, consisting of—

16 “(i) the 7.5-mile segment from its
17 source to the end of Forest Road 30710,
18 as a wild river; and

19 “(ii) the 17-mile segment from the
20 mouth of Cliff Creek to its confluence with
21 the Snake River, as a recreational river.

22 “(I) LEWIS RIVER.—The portions of the
23 Lewis River, consisting of—

1 “(i) the 5-mile segment from Sho-
2 shone Lake to Lewis Lake, as a wild river;
3 and

4 “(ii) the 12-mile segment from the
5 outlet of Lewis Lake to its confluence with
6 the Snake River, as a scenic river.

7 “(J) PACIFIC CREEK.—The portions of Pa-
8 cific Creek, consisting of—

9 “(i) the 22.5-mile segment from its
10 source to the Teton Wilderness boundary,
11 as a wild river; and

12 “(ii) the 11-mile segment from the
13 Wilderness boundary to its confluence with
14 the Snake River, as a scenic river.

15 “(K) SHOAL CREEK.—The 17-mile seg-
16 ment from its source to its confluence with the
17 Hoback River, as a wild river.

18 “(L) SNAKE RIVER.—The portions of the
19 Snake River, consisting of—

20 “(i) the 47-mile segment from its
21 source to Jackson Lake, as a wild river;

22 “(ii) the 24.8-mile segment from 1
23 mile downstream of Jackson Lake Dam to
24 1 mile downstream of the Teton Park

1 Road bridge at Moose, Wyoming, as a see-
 2 nie river, and

3 “(iii) the 20-mile segment from the
 4 mouth of the Hoback River to Palisades
 5 Reservoir, as a recreational river.

6 “(M) WILLOW CREEK.—The 21-mile seg-
 7 ment from its source to its confluence with the
 8 Hoback River, as a wild river.

9 “(N) WOLF CREEK.—The 7-mile segment
 10 from its source to its confluence with the Snake
 11 River, as a wild river.”.

12 **SEC. 5. MANAGEMENT.**

13 (a) IN GENERAL.—Each river segment described in
 14 paragraph (170) of section 3(a) of the Wild and Scenic
 15 Rivers Act (16 U.S.C. 1274(a)) (as added by section 4(4))
 16 shall be managed by the Secretary concerned.

17 (b) MANAGEMENT PLAN.—Not later than 3 years
 18 after the date of enactment of this Act, the Secretary con-
 19 cerned shall develop a management plan for each river
 20 segment described in paragraph (170) of section 3(a) of
 21 the Wild and Scenic Rivers Act (16 U.S.C. 1274(a)) (as
 22 added by section 4(4)) that is located in an area under
 23 the jurisdiction of the Secretary concerned.

24 (c) FEDERAL RESERVED WATER RIGHT.—

1 (1) IN GENERAL.—Subject to paragraph (2), in
2 accordance with the laws (including regulations) of
3 the State, the Secretary concerned shall apply for
4 the quantification of the water right reserved by
5 each river segment described in paragraph (170) of
6 section 3(a) of the Wild and Scenic Rivers Act (16
7 U.S.C. 1274(a)) (as added by section 4(4)) that is
8 located in an area under the jurisdiction of the Sec-
9 retary concerned.

10 (2) REQUIREMENTS.—Notwithstanding any law
11 (including a regulation) of the State relating to the
12 granting or exercising of any water right, each river
13 segment that is the subject of an application under
14 paragraph (1) shall—

15 (A) be designated for a beneficial use; and

16 (B) have a priority date that is the date of
17 enactment of this Act.

18 **SEC. 6. AUTHORIZATION OF APPROPRIATIONS.**

19 There are authorized to be appropriated—

20 (1) \$350,000 to develop a management plan for
21 each river segment described in paragraph (170) of
22 section 3(a) of the Wild and Scenic Rivers Act (16
23 U.S.C. 1274(a)) (as added by section 4(4)) that is
24 located in the Bridger-Teton National Forest; and

1 ~~(2) \$250,000 to develop a management plan for~~
 2 ~~each river segment described in paragraph (170) of~~
 3 ~~section 3(a) of the Wild and Scenic Rivers Act (16~~
 4 ~~U.S.C. 1274(a)) (as added by section 4(4)) that is~~
 5 ~~located in Grand Teton National Park.~~

22 *rivers and streams.*

23 *(b) PURPOSES.—The purposes of this Act are—*

25 *of citizens of the United States the outstandingly re-*

1 *markable scenic, natural, wildlife, fishery, rec-*
2 *reational, scientific, historic, and ecological values of*
3 *the rivers and streams of the headwaters of the Snake*
4 *River System, while continuing to deliver water and*
5 *operate and maintain valuable irrigation water in-*
6 *frastructure; and*

7 (2) *to designate approximately 387.7 miles of the*
8 *rivers and streams of the headwaters of the Snake*
9 *River System as additions to the National Wild and*
10 *Scenic Rivers System.*

11 **SEC. 3. DEFINITIONS.**

12 *In this Act:*

13 (1) *SECRETARY CONCERNED.*—*The term “Sec-*

11 (2) *STATE.—The term “State” means the State*

13 **SEC. 4. WILD AND SCENIC RIVER DESIGNATIONS, SNAKE**
 14 **RIVER SYSTEM.**

15 Section 3(a) of the Wild and Scenic Rivers Act (16
 16 U.S.C. 1274(a)) is amended—

17 (1) *by redesignating paragraph (167) (relating*
 18 *to the Musconetcong River, New Jersey) as paragraph*
 19 *(169);*

20 (2) *by designating the undesignated paragraph*
 21 *relating to the White Salmon River, Washington, as*
 22 *paragraph (167);*

23 (3) *by designating the undesignated paragraph*
 24 *relating to the Black Butte River, California, as*
 25 *paragraph (168); and*

1 (4) *by adding at the end the following:*

2 “(170) *WILD AND SCENIC RIVER DESIGNATIONS,*
3 *SNAKE RIVER SYSTEM.—The following segments of the*
4 *Snake River System, in the State of Wyoming:*

5 “(A) *BAILEY CREEK.—The 7-mile segment*
6 *of Bailey Creek, from the divide with the Little*
7 *Greys River north to its confluence with the*
8 *Snake River, as a wild river.*

9 “(B) *BLACKROCK CREEK.—The 22-mile seg-*
10 *ment from its source to the Bridger-Teton Na-*
11 *tional Forest boundary, as a scenic river.*

12 “(C) *BUFFALO FORK OF THE SNAKE*
13 *RIVER.—The portions of the Buffalo Fork of the*

3 “(D) CRYSTAL CREEK.—*The portions of*
4 *Crystal Creek, consisting of—*

5 “(i) *the 14-mile segment from its*
6 *source to the Gros Ventre Wilderness bound-*
7 *ary, as a wild river; and*

8 “(ii) *the 5-mile segment from the Gros*
9 *Ventre Wilderness boundary to its con-*
10 *fluence with the Gros Ventre River, as a sce-*
11 *nic river.*

12 “(E) GRANITE CREEK.—*The portions of*
13 *Granite Creek, consisting of—*

14 “(i) *the 12-mile segment from its*
15 *source to the end of Granite Creek Road, as*
16 *a wild river; and*

17 “(ii) *the 9.5-mile segment from Gran-*
18 *ite Hot Springs to the point 1 mile up-*
19 *stream from its confluence with the Hoback*
20 *River, as a scenic river.*

21 “(F) GROS VENTRE RIVER.—*The portions of*
22 *the Gros Ventre River, consisting of—*

23 “(i) *the 16.5-mile segment from its*
24 *source to Darwin Ranch, as a wild river;*

1 “(ii) the 39-mile segment from Darwin
2 Ranch to the upstream boundary of Grand
3 Teton National Park, excluding the section
4 along Lower Slide Lake, as a scenic river;
5 and

6 “(iii) the 3.3-mile segment flowing
7 across the southern boundary of Grand
8 Teton National Park to the Highlands
9 Drive Loop Bridge, as a scenic river.

10 “(G) HOBACK RIVER.—The 10-mile segment
11 from the point 10 miles upstream from its con-
12 fluence with the Snake River to its confluence
13 with the Snake River, as a recreational river.

14 “(H) LEWIS RIVER.—The portions of the
15 Lewis River, consisting of—

16 “(i) the 5-mile segment from Shoshone
17 Lake to Lewis Lake, as a wild river; and

18 “(ii) the 12-mile segment from the out-
19 let of Lewis Lake to its confluence with the
20 Snake River, as a scenic river.

21 “(I) PACIFIC CREEK.—The portions of Pa-
22 cific Creek, consisting of—

23 “(i) the 22.5-mile segment from its
24 source to the Teton Wilderness boundary, as
25 a wild river; and

1 “(ii) the 11-mile segment from the Wil-
2 derness boundary to its confluence with the
3 Snake River, as a scenic river.

4 “(J) SHOAL CREEK.—The 8-mile segment
5 from its source to the point 8 miles downstream
6 from its source, as a wild river.

7 “(K) SNAKE RIVER.—The portions of the
8 Snake River, consisting of—

9 “(i) the 47-mile segment from its
10 source to Jackson Lake, as a wild river;

11 “(ii) the 24.8-mile segment from 1 mile
12 downstream of Jackson Lake Dam to 1 mile
13 downstream of the Teton Park Road bridge
14 at Moose, Wyoming, as a scenic river; and

15 “(iii) the 19-mile segment from the
16 mouth of the Hoback River to the point 1
17 mile upstream from the Highway 89 bridge
18 at Alpine Junction, as a recreational river,
19 the boundary of the western edge of the cor-
20 ridor for the portion of the segment extend-
21 ing from the point 3.3 miles downstream of
22 the mouth of the Hoback River to the point
23 4 miles downstream of the mouth of the
24 Hoback River being the ordinary high water
25 mark.

1 “(L) *WILLOW CREEK.*—*The 16.2-mile seg-*
2 *ment from the point 16.2 miles upstream from*
3 *its confluence with the Hoback River to its con-*
4 *fluence with the Hoback River, as a wild river.*

5 “(M) *WOLF CREEK.*—*The 7-mile segment*
6 *from its source to its confluence with the Snake*
7 *River, as a wild river.”.*

8 **SEC. 5. MANAGEMENT.**

9 (a) *IN GENERAL.*—*Each river segment described in*
10 *paragraph (170) of section 3(a) of the Wild and Scenic Riv-*
11 *ers Act (16 U.S.C. 1274(a)) (as added by section 4(4)) shall*
12 *be managed by the Secretary concerned.*

13 (b) *MANAGEMENT PLAN.*—

14 (1) *IN GENERAL.*—*In accordance with para-*
15 *graph (2), not later than 3 years after the date of en-*
16 *actment of this Act, the Secretary concerned shall de-*
17 *velop a management plan for each river segment de-*
18 *scribed in paragraph (170) of section 3(a) of the Wild*
19 *and Scenic Rivers Act (16 U.S.C. 1274(a)) (as added*
20 *by section 4(4)) that is located in an area under the*
21 *jurisdiction of the Secretary concerned.*

22 (2) *REQUIRED COMPONENT.*—*Each management*
23 *plan developed by the Secretary concerned under*
24 *paragraph (1) shall contain, with respect to the river*
25 *segment that is the subject of the plan, a section that*

1 *contains an analysis and description of the avail-*
2 *ability and compatibility of future development with*
3 *the wild and scenic character of the river segment*
4 *(with particular emphasis on each river segment that*
5 *contains 1 or more parcels of private land).*

6 (c) *QUANTIFICATION OF WATER RIGHTS RESERVED BY*
7 *RIVER SEGMENTS.—*

8 (1) *The Secretary concerned shall apply for the*
9 *quantification of the water rights reserved by each*
10 *river segment designated by this Act in accordance*
11 *with the procedural requirements of the laws of the*
12 *State of Wyoming.*

13 (2) *For the purpose of the quantification of*
14 *water rights under this subsection, with respect to*
15 *each Wild and Scenic River segment designated by*
16 *this Act—*

17 (A) *the purposes for which the segments are*
18 *designated, as set forth in this Act, are declared*
19 *to be beneficial uses; and*

20 (B) *the priority date of such right shall be*
21 *the date of enactment of this Act.*

22 (d) *STREAM GAUGES.—Consistent with the Wild and*
23 *Scenic Rivers Act (16 U.S.C. 1271 et seq.), the Secretary*
24 *may carry out activities at United States Geological Survey*
25 *stream gauges that are located on the Snake River (includ-*

1 *ing tributaries of the Snake River), including flow measure-*
 2 *ments and operation, maintenance, and replacement.*

3 (e) *CONSENT OF PROPERTY OWNER.—No property or*
 4 *interest in property located within the boundaries of any*
 5 *river segment described in paragraph (170) of section 3(a)*
 6 *of the Wild and Scenic Rivers Act (16 U.S.C. 1274(a)) (as*
 7 *added by section 4(4)) may be acquired by the Secretary*
 8 *without the consent of the owner of the property or interest*
 9 *in property.*

10 (f) *EFFECT OF DESIGNATIONS.—*

11 (1) *IN GENERAL.—Nothing in this Act affects*
 12 *valid existing rights, including—*

13 (A) *all interstate water compacts in exist-*
 14 *ence on the date of enactment of this Act (includ-*
 15 *ing full development of any apportionment made*
 16 *in accordance with the compacts);*

17 (B) *water rights in the States of Idaho and*
 18 *Wyoming; and*

19 (C) *water rights held by the United States.*
