## A BILL

To toll the congressional notification period for removing North Korea from the state sponsors of terrorism list.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REQUIREMENT TO TOLL CONGRESSIONAL NO-**  
4 **TIFICATION PERIOD FOR REMOVING NORTH**  
5 **KOREA FROM THE STATE SPONSORS OF TER-**  
6 **RORISM LIST.**

7 (a) REQUIREMENT.—

8 (1) IN GENERAL.—Beginning on the date of the  
9 enactment of this Act, the 45-day period referred to

1 in the provisions of law described in paragraph (2)  
2 shall be tolled with respect to any rescission of the  
3 determination of the Secretary of State that the  
4 Government of North Korea has repeatedly provision  
5 support for acts of international terrorism pursuant  
6 to such provisions of law until the President certifies  
7 to Congress that North Korea meets the conditions  
8 described in subsection (b).

9 (2) PROVISIONS OF LAW DESCRIBED.—The pro-  
10 visions of law referred to in paragraph (1) are sec-  
11 tion 620A of the Foreign Assistance Act of 1961 (22  
12 U.S.C. 2371), section 40 of the Arms Export Con-  
13 trol Act (22 U.S.C. 2780), and section 6(j) of the  
14 Export Administration Act of 1979 (50 U.S.C. App.  
15 2405(j)).

16 (b) CONDITIONS DESCRIBED.—The conditions re-  
17 ferred to in subsection (a) are the following:

18 (1) The Government of North Korea has made  
19 a complete and verifiable declaration regarding the  
20 existence, number, and disposition of any assembled  
21 or partially assembled nuclear explosive devices.

22 (2) The Government of North Korea has made  
23 a complete and verifiable declaration regarding at-  
24 tempts to enrich uranium or develop the capability  
25 to do so.

1           (3) The Government of North Korea has made  
2           a complete and verifiable declaration regarding nu-  
3           clear assistance provided to any other countries.
