## A BILL

To amend the Dayton Aviation Heritage Preservation Act of 1992 to add sites to the Dayton Aviation Heritage National Historical Park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may cited as the “Dayton Aviation National  
5 Historical Park Expansion Act”.

6 **SEC. 2. INCLUSION OF ADDITIONAL AREAS.**

7 Section 101 of the Dayton Aviation Heritage Preser-  
8 vation Act of 1992 (16 U.S.C. 410ww) is amended by add-  
9 ing at the end the following:

1       “(c) ADDITIONAL SITES.—In addition to the sites de-  
2 scribed in subsection (b), the park shall consist of the fol-  
3 lowing sites, as generally depicted on the map entitled  
4 ‘Dayton Aviation Heritage National Historical Park’,  
5 numbered 362/80,013, and dated May 2008:

6               “(1) Hawthorn Hill, Oakwood, Ohio.

7               “(2) The Wright Company factory and associ-  
8 ated land and buildings, Dayton, Ohio.”.

9 **SEC. 3. PROTECTION OF HISTORIC PROPERTIES.**

10       Section 102 of the Dayton Aviation Heritage Preser-  
11 vation Act of 1992 (16 U.S.C. 410ww–1) is amended—

12               (1) in subsection (a), by inserting “Hawthorn  
13 Hill, the Wright Company factory,” after “, ac-  
14 quire”; and

15               (2) by striking subsection (b) and inserting the  
16 following:

17       “(b) COOPERATIVE AGREEMENTS.—

18               “(1) IN GENERAL.—The Secretary may enter  
19 into cooperative agreements with other Federal  
20 agencies, States, local units of governments, and pri-  
21 vate interests and organizations relating to the pres-  
22 ervation, development, use, and interpretation of  
23 properties within the boundaries of the park in order  
24 to contribute to the appropriate use and manage-

1       ment of the properties, consistent with the purposes  
2       of this Act.

3               “(2) OPERATION OF HAWTHORN HILL.—The  
4       Secretary may enter into a cooperative agreement  
5       with 1 or more partners, including the Wright Fam-  
6       ily Foundation—

7                       “(A) to operate and provide programming  
8                       for Hawthorn Hill; and

9                       “(B) notwithstanding any other provision  
10                      of law, to charge reasonable fees relating to the  
11                      use of, or access to, Hawthorn Hill, which may  
12                      be used to defray the costs of park operation  
13                      and programming.

14               “(3) REQUIREMENTS.—Cooperative agreements  
15       under this section shall provide, as appropriate,  
16       that—

17                       “(A) the public may have access to any  
18                       property at specified reasonable times for pur-  
19                       poses of—

20                               “(i) viewing the property or the exhib-  
21                               its; or

22                               “(ii) attending programs established  
23                               by the Secretary under this subsection; and

24                       “(B) the Secretary may make any improve-  
25                       ments to the property as the Secretary, after

1           consultation with the Aviation Heritage Foun-  
2           dation, determines to be necessary to enhance  
3           the public use and enjoyment of the property  
4           and programs.”.
